While this is not an exhaustive list to govern your entire term, it can get you started on the tasks you will need to complete during your first 30 days in office.

- ☐ Submit your updated officer and key committee chairman contact information to National Headquarters.
  - Work with the outgoing secretary to complete the Officer Election Report on Chapter Gateway [Membership Management → Actions → Update Officer Information (GR Part 4)].
- □ Submit your updated officer and key committee chairman contact information to the appropriate campus offices (e.g., student activities, fraternity/sorority life, etc.).
- ☐ Register for Pi Kapp College for Chapter Officers.
  - Required officers will receive an email with registration information.
  - Check the Events section of pikapp.org for the most up-to-date information.
- ☐ Update officers in OmegaFi.
  - Work with the outgoing archon and treasurer to update your list of officers with your chapter services representative.
  - Update user permissions in OmegaFi to allow necessary user access.

## **MEET WITH YOUR CONTACTS**

- ☐ Meet with the outgoing archon to transition your roles.
  - Review the chapter's current strategic plan and any upcoming projects and events.
  - Review the chapter's Founders' Report for the current semester.
  - Discuss successes, challenges and other issues encountered during his term in office.
  - Gather suggestions on how to lead the chapter effectively in the coming year.
- ☐ Contact your chapter advisor.
  - Set up a time to meet/talk in the next two weeks.
  - Review your position description and set expectations together.
  - Provide the contact information for all newly elected or re-elected officers.
  - Share the date, time and location for the chapter's <u>officer transition meeting</u>, and invite your chapter advisor to attend.
  - Set up a time and method for weekly communication.
- ☐ Contact your housing corporation president (if applicable).
  - Set up a time to meet/talk in the next two weeks.
  - Review your position description and set expectations together.
  - Provide the contact information for all newly elected or re-elected officers.
  - Review any outstanding balances with the housing corporation and establish clear payment deadlines.
  - Set up a time and method for ongoing communication.
  - Ensure the treasurer also meets/talks to the housing corporation president.

	Contact your <u>director of chapter services</u> to introduce yourself.					
RE	VIEW THE CHAPTER'S STATUS					
	Obtain (from your <u>director of chapter services</u> or outgoing officers) and review copies of your chapter's current:  Constitution and Bylaws  Strategic Plan  Budget  Founders' Report on Chapter Gateway [Administrative Items → Founders' Report → Reports → Founders' Report (By Term & Year)]  Events calendar and the campus academic and activities calendar  Membership Roster on Chapter Gateway [Membership Management → Reports → Current Chapter Roster]  If applicable, any current risk management sanctions/action plans from the university, IFC or Pi Kappa Phi					
	Check your chapter's account balance with IFC or any other campus board/council (e.g., All-Greek Programming Board, Greek Council, Multi-Cultural Council, etc.).					
	Check current account balances for checking, savings and miscellaneous accounts (housing fund, scholarship fund, The Ability Experience fund, OmegaFi Bill Pay).					
	Make signature changes for the checking account at the bank.					
	Schedule and lead the <u>officer transition retreat</u> (available in the Governance section of the <u>Resource Library on pikapp.org</u> ).
